# 1704 LETTER FROM THE CHAIR

With the Thanksgiving holiday around the corner, I must reflect on many events which occurred that I am very grateful for this year. On July 17, 2023, we were all awakened with the news of a train derailment in Whitemarsh Township. Thankfully, there were no reported injuries and no known hazards to the public. I wish to thank our Emergency Response Team for their quick response and management of this situation. We were very lucky to have the knowledge and expertise of our police, fire, ambulance, and emergency management team to oversee this incident.

We had two fun-filled annual Township events in 2023; the first on April 22, 2023, where we celebrated Township Day with thousands of residents at Victory Field on the Plymouth-Whitemarsh High School Campus. Then on July 4th, the fun and tradition of the Whitemarsh 4th of July Parade again marched down Germantown Pike to Miles Park to celebrate our Independence. Thanks to the Parks and Recreation Department in managing both successful events.

At the Board of Supervisors Meeting on July 13, 2023, the Environmental Advisory Board presented Ordinance #1029 to restrict the distribution of single-use plastic bags throughout the Township. The ordinance was enacted. This means that beginning **October 11, 2023, Whitemarsh businesses will be prohibited from providing single-use plastic bags at checkout.** Consumers are encouraged to bring reusable bags, or they may purchase paper bags with at least **40% post-consumer recycled content** at a nominal charge.

In August, three individuals in the Whitemarsh Police Department received promotions to the ranks of Lieutenant, Sergeant, and Corporal. Congratulations to Lieutenant Amanda Johnson, Sergeant Mark Williams, and Corporal Michael Hannon to their new positions and thank you for your continued service to the Whitemarsh Community.

On September 30, 2023, with the oversight and sponsorship from the Shade Tree Commission, 260 native trees were provided to residents of the Township to enhance the beauty and health of the area! Many thanks to all the volunteers who helped with this program. The addition of trees is a reminder that the Public Works Department will be starting their leaf collection program on **October 23, 2023, through December 8, 2023.**

With the holidays approaching, the Whitemarsh Township Board of Supervisors would like to thank the residents for a good year and wish everyone a Happy and Healthy Holiday Season. 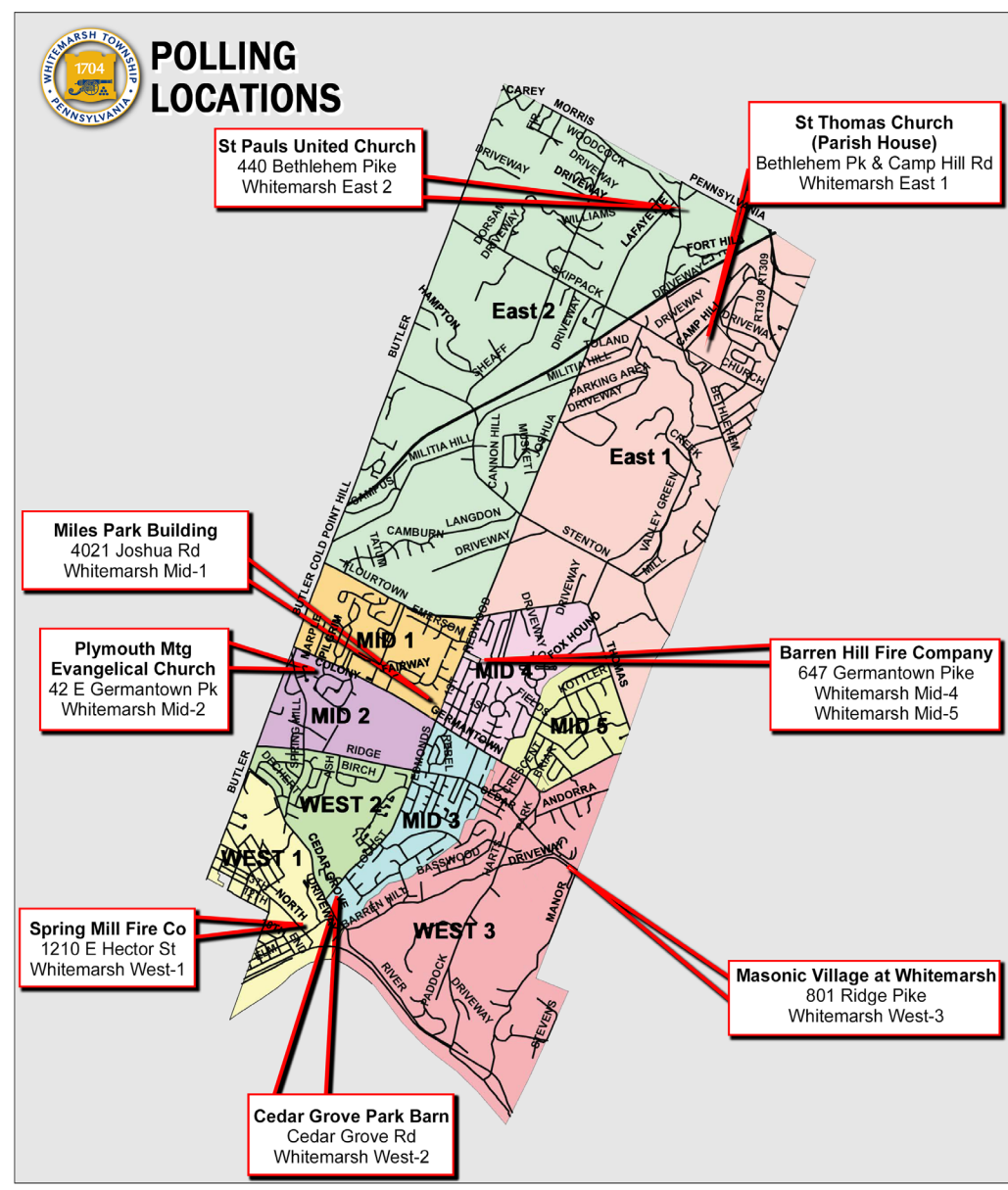

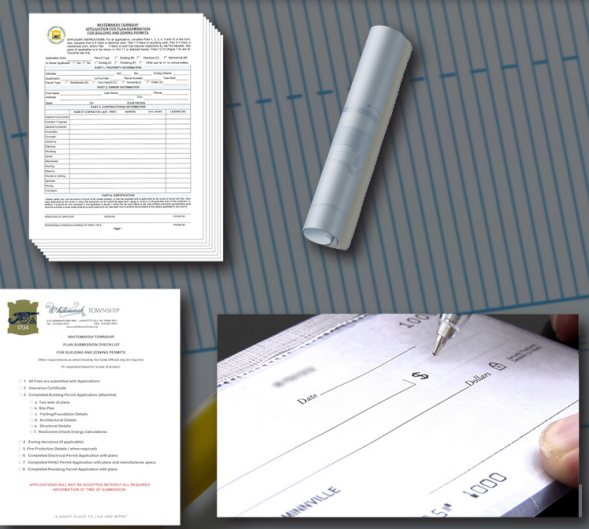

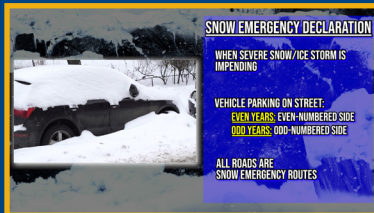

Dear Resident,

This is a friendly reminder about winter road snow removal operations. Please see the attached illustration (*next page*) of parking at the end of your driveway. This illustration will help you as the resident and the Township truck operator.

Each year, with the first snowfall, the Township is flooded with telephone calls regarding the rules and policies affecting snow removal. Please note the following:

- Depending on snow/rain amounts, the Highway Department will start to brine the roads 24-48 hours prior to a snow event.
- As soon as snow or freezing rain begins, the Highway Department starts salting and applying cinders on Township roads. Snow plowing begins when the snow depth reaches 3 - 4 inches.
- Many of our arterial roadways, such as Germantown Pike, Joshua Road, Ridge Pike, North Lane, Cedar Grove Road, Skippack Pike, Bethlehem Pike, Pennsylvania Avenue, Stenton Avenue, Flourtown Road, Militia Hill Road and Butler Pike are not maintained by the Township, as these roads are owned and maintained by PennDOT or Montgomery County.
- Please limit vehicle parking in Cul-de-sacs, to assist the snowplow operators.
- The Township Code prevents residents from shoveling, blowing, or plowing snow into any roadway.
- To assist with snow and ice removal, the Township Code requires all vehicles to be parked off-street when snow reaches a depth of 3 to 4 inches requiring plowing. Residents and businesses without sufficient off-street parking are required to adhere to the following schedule:

**On even-numbered calendar years (2022, 2024, etc.), parking is permitted on the side of the street with even-numbered addresses.**

**On odd-numbered calendar years (2023, 2025, etc.), parking is permitted on the side of the street with odd-numbered addresses.**

**On streets with permanent parking restrictions (No Parking Here to Corner, No Parking, etc.), the permanent restrictions shall prevail.**

- The Township Police Department will strictly enforce these regulations during winter storms in order to insure that the Public Works Department can plow, salt and cinder the roads to make them passable and safe for everyone. Violators are subject to fines up to \$1,000.
- Residents and business owners also are reminded that all sidewalks and parking lots must be cleared of snow and ice within 24 hours of the end of a snowfall. Compliance with this ordinance allows for pedestrian passage, particularly elementary school children walking to school.
- The U.S. Postal Service requests the cooperation of postal customers in keeping walkways and curbside mailboxes clear of snow and ice, in order to ensure the safe and efficient delivery of mail this winter. Letter carriers are especially vulnerable to slips, trips and falls during the winter months.

Residents who receive mail delivery to curbside boxes are asked to keep the approach to and exit from their mailbox clear of snow, ice, vehicles, trash cans and other objects.

- If there is a fire hydrant near your house, do your part to keep it accessible this winter. Remove any snow and ice, clear a wide enough perimeter (recommend 3 feet) around the hydrant for firefighters to work, and clear a path from hydrant to street. Every second counts in an emergency by doing your part you may save a property or a life.

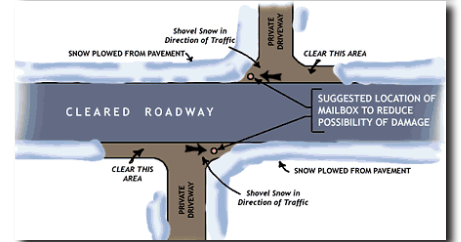
The cooperation of all Township residents and businesses is greatly appreciated during winter storms.

**Tips for Clearing Snow**

- Wait until the snowplows have made a first pass before clearing your driveway. Be sure snow piles are located to the right of your driveway. This way, less snow will be re-directed into the driveway with each passing truck.
- Know the Township's snow emergency parking regulations. Stay tuned to KYW (1060 AM or 103.9 FM) for all snow emergency announcements.
- Clear your sidewalks and curbs. Neighborhood children need safe access to schools and bus stops throughout the winter months. Clearing your sidewalk helps children travel to school safely.
- Be patient. State, County, and Township crews will work around the clock, if needed, to ensure all roadways are cleared as quickly as possible.

Thank you, and we appreciate your patience during winter storms. Please note that the Public Works Department will do everything possible to clean up all Township roadways safely, efficiently, and as quickly as possible.

**2023 Leaf Collection & Composting Program**

Each Fall, the Public Works Department collects an average of 1,500 tons of leaves from every curb in Whitemarsh Township. Leaf collection typically runs once a week (weather permitting) between October and December. These leaves then undergo a months-long process at our Public Works Building that turn them into mulch. Typically by mid-summer, the mulch becomes available for residents to purchase and use.



**2023 Collections will start OCTOBER 23rd, and run through DECEMBER 8th (weather dependent).**

To ensure proper curbside collection, and the safety of our Public Works crews and equipment, residents should:

- **Keep sticks, debris and waste out of leaf piles**
- **Do NOT bag leaves! Bagged leaves cannot be collected by our machines.**

It is hard to believe that 2023 is nearing the end of the year already. The men and women of the Police Department have spent another year working tirelessly to "serve, protect, and defend" our community. With the help of our residents, we have continued to make Whitemarsh Township a safe and enjoyable place to live, work and visit. We have seen a reduction in the number of vehicle break-ins, from years prior, and an increase in traffic enforcement activities to help keep our community safe.

The Whitemarsh Township Police Department received our fifth re-accreditation from the Pennsylvania Chiefs of Police Association in 2023. This puts our department in Premier Agency Status, which recognizes the top echelon of agencies in Pennsylvania that have remained committed to state accreditation. Premier Status recognizes those agencies that have attained certain longevity (15 years) in accreditation, remained committed to a philosophy of excellence, and a sustained level of commitment. Whitemarsh Township Police Department is one of only 27 agencies in the state to reach this level.

As we all know by this point of the year, Montgomery County has begun the Ridge Pike Improvement Project on the east end of Ridge Pike, from Crescent Avenue through Springfield Township to the Philadelphia City Line. We still face many months of road work ahead in this area. Naturally, this roadwork will cause delays in the area, so please plan on alternative routes or extended travel times. This construction, in our community, will lead to traffic issues. The Police Department will continue to address these issues to the best of our abilities. We will monitor traffic issues for both safety and public convenience and we will address hazardous conditions and reckless driving behavior wherever it is found. We all face the same inconvenience, delays, and detours, so let's all be good neighbors and citizens and work together to get through it. If we weather this storm together, we will show that Whitemarsh is a strong and caring community for people to live and/or work here.

Speaking of storms, since we encounter flooding here in Whitemarsh Township, we remind our residents if you see a flooded roadway, please "Turn Around Don't Drown." Each year, more deaths occur due to flooding than from any other thunderstorm-related hazard. People underestimate the force and power of water. Never drive around barriers blocking a flooded roadway and never drive through a water-covered roadway.

As the Chief of Police, I want to thank our residents for securing their vehicles and homes over this year, reducing thefts, and ask that you continue to do so. I also want to thank all our Officers and employees for their continued dedicated work with the community and the residents, as we continue to make Whitemarsh Township "a great place to live and work" as we move into 2024! I encourage you to call us if you see anything suspicious; if you see something out of the ordinary, please say something.

I wish everyone a happy and healthy 2024 and thank you for your continued support!

It didn't take long for Andrew to get tossed into an emergency. He was a key part of the response to the train derailment on July 17th.

Andrew is a resident of Plymouth Township, where he lives with his wife, Karlie, and son Grayson. In his spare time, Andrew enjoys being with his family, down the shore and fishing.

**SMOKE ALARMS SAVE LIVES**

Smoke alarms are needed in your home! They should be in the following locations:

- One on each floor
- Outside of sleeping areas, like in a hallway
- One in each sleeping area, like each person's bedroom



If you don't have smoke alarms in these locations, or do not know, contact the Whitemarsh Fire Marshal's Office at **484-594-2614**, or email the Fire Marshal at **ATHOMAS@WHITEMARSH TWP.ORG**; and we can arrange for residents to get them.

Whitemarsh Township, Barren Hill, and Spring Mill Fire Companies partner with **6ABC Operation Save a Life** to provide 10-year lithium-ion-battery smoke alarms to residents at no cost.

**Cooking Safety**

Cooking brings family and friends together, provides an outlet for creativity and can be relaxing. But did you know that cooking fires are the number one cause of home fires and home injuries? By following a few safety tips you can prevent these fires.

**"COOK WITH CAUTION"**

- Be on alert! If you are sleepy or have consumed alcohol don't use the stove or stovetop.
- Stay in the kitchen while you are frying, boiling, grilling, or broiling food. If you leave the kitchen for even a short period of time, turn off the stove.
- If you are simmering, baking, or roasting food, check it regularly, remain in the home while food is cooking, and use a timer to remind you that you are cooking.
- Keep anything that can catch fire — oven mitts, wooden utensils, food packaging, towels or curtains — away from your stovetop.



**Cooking and Kids**

Have a "kid-free zone" of at least 3 feet (1 metre) around the stove and areas where hot food or drink is prepared or carried.

**If you have a small (grease) cooking fire and decide to fight the fire...**

- On the stovetop, smother the flames by sliding a lid over the pan and turning off the burner. Leave the pan covered until it is completely cooled.
- For an oven fire, turn off the heat and keep the door closed.

**If you have any doubt about fighting a small fire...**

- Just get out! When you leave, close the door behind you to help contain the fire.
- Call 9-1-1 or the local emergency number from outside the home.

- ! The leading cause of fires in the kitchen is unattended cooking.
- ! Most cooking fires in the home involve the kitchen stove.

# Electrical Safety



Flipping a light switch. Plugging in a coffemaker. Charging a laptop computer. These are second nature for most of us. Electricity makes our lives easier. However, we need to be cautious and keep safety in mind.

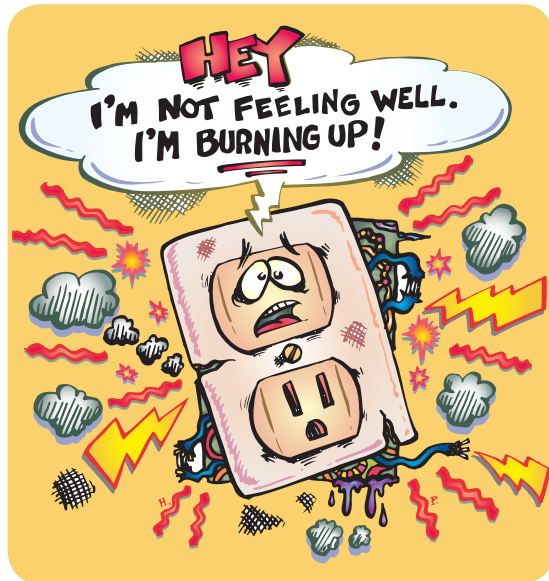
### SAFETY TIPS

- Have all electrical work done by a qualified electrician.
- When you are buying or remodeling a home, have it inspected by a qualified private inspector or in accordance with local requirements.
- Only use one heat-producing appliance (such as a coffee maker, toaster, space heater, etc.) plugged into a receptacle outlet at a time.
- Major appliances (refrigerators, dryers, washers, stoves, air conditioners, microwave ovens, etc.) should be plugged directly into a wall receptacle outlet. Extension cords and plug strips should not be used.
- Arc-fault circuit interrupters (AFCIs) shut off electricity when a dangerous condition occurs. Consider having them installed in your home.
- Use ground-fault circuit interrupters (GFCIs) to reduce the risk of shock. GFCIs shut off an electrical circuit when it becomes a shock hazard. They should be installed inside the home in bathrooms, kitchens, garages and basements. All outdoor receptacles should be GFCI protected.
- Test AFCIs and GFCIs once a month according to the manufacturer's recommendations. You do not need a flame to start a fire. Fires can start when heat builds up near things that burn. This can happen when a hot light bulb is near things that burn, such as cloth or paper, or a cord has been placed under a carpet.
- Check electrical cords to make sure they are not running across doorways or under carpets. Extension cords are intended for temporary use. Have a qualified electrician add more receptacle outlets so you don't have to use extension cords.
- Use a light bulb with the right number of watts. There should be a sticker that indicates the right number of watts.

### IMPORTANT REMINDER

Call a qualified electrician or your landlord if you have:

- Frequent problems with blowing fuses or tripping circuit breakers
- A tingling feeling when you touch an electrical appliance
- Discolored or warm wall outlets
- A burning or rubbery smell coming from an appliance
- Flickering or dimming lights
- Sparks from an outlet

## HOW YOUR SUPPORT SAVED A LIFE

It was 5:55 am, and our crew was about to start their 12-hour shift. Our Paramedic and EMT arrived about 30 minutes earlier to conduct their truck and medical supply inspection, making sure everything was fully stocked and the equipment ready to operate properly.

The station buzzer sounds, the Active911 smartphone app tone is on, the crew members' phones also ring, indicating Montgomery County 911 was dispatching us for a call. The fire company and police are also being dispatched. The call is a cardiac arrest. "Time is heart," as they say, and quick action is absolutely critical.

After the dispatch, we were on scene within two minutes. CPR is in progress, compressions are being done, the patient is being given oxygen, but it's not enough; the patient needs to be intubated so that we can breathe for them. The medic is focused and was able to intubate the patient while CPR continued, lifesaving medications are administered through a skillfully-placed IV. Seven grueling minutes have gone by as the team effort continues. The medic asks for everyone to pause so that they can check the monitor, there's a heart rhythm, the medic asks everyone to check for pulses, the patient has a pulse! Now our protocol changes;

we have to keep this person alive and get them to the hospital ASAP.

But imagine it unfolded differently. If, for example, our personnel didn't have the training or equipment to perform life-saving CPR. Or, if there had been no ambulance nearby since minutes count when someone's heart has stopped. Or, if medical supplies were in short supply. The patient might never have been revived.

It could have happened.

There is only one reason it didn't, and it is **you**.

## RIDGE PIKE IMPROVEMENT PROJECT STATUS REPORT

### Section D (Crescent Avenue to Northwestern Avenue):

Since the last update, the project has progressed to Stage 2 (road widening), with only one lane open in both directions throughout the entire project area. Aqua Pennsylvania has completed the relocation of their water main from the westbound (from Philadelphia) side of the road between Manor and Barren Hill Roads to the eastbound (towards Philadelphia) side. PECO Gas will begin lowering their gas main at the intersection of Barren Hill Road and Ridge Pike at the end of August 2023; this will force Barren Hill Road to close near Ridge Pike during September and October. PECO Electric is anticipating a 6-hour power outage at the intersection of Manor Road and Ridge Pike, affecting the Atria Senior Living facility and the Squires Ridge development behind it in approximately mid-September. Montgomery County will send out an email notice when we have a firm date from PECO; if you are not signed up already for the County's email notices, please visit their website to do so. This power outage will occur overnight in order to have less effect on residents and the travelling public. We are anticipating completion of Section D of the Ridge Pike Improvement Project by the end of 2024. Updates and detours will be posted regularly on our project website.



### Section C (Harmon Road to Crescent Avenue):

The County is actively progressing the final design stage of this section of the project, and have begun the right-of-way phase. Some residents may have received a Notice of Intent to Enter letter from the County. This does not mean that the County will be purchasing some or all of your property for infrastructure improvements; it just means that they need access to your property to conduct surveys, assessments or studies in support of the larger roadway improvements. If Section C's construction will directly affect your property, a county representative will be in contact with you during the final design process. Construction for Section C is anticipated to begin in late 2025.

For those residents travelling further west on Ridge Pike towards Norristown, Section B of this project (between Belvoir Road and Chemical Road in Plymouth Township) will also begin construction this Fall.

## ZONING ORDINANCE UPDATE: PHASE 1 UPDATE

A Steering Committee was established early in 2021 to assist the Township and its consultant in preparation of the first phase of the Zoning Ordinance Update, which is intended to implement recommendations that are contained in the 'Selective Comprehensive Plan Update' adopted in November 2020. The Committee consists of representatives from the Board of Supervisors, Planning Commission, other boards and commissions, the Township Engineer and staff. The Update Steering Committee is working with our consultant, Kimberly Baptiste from Bergmann (a consulting firm of architects, planners, and engineers) guiding the Committee's work.

Beginning in the Fall of 2022, the Committee and consultant started work on a zoning analysis and potential revision options that would be appropriate for underdeveloped and other parcels identified in the recently adopted Spring Mill Multi-Modal and Land Use Study, completed in May and adopted by the Board of Supervisors as an amendment to the Township's Comprehensive Plan, in June. This zoning work is being done based upon the land use policies in that study as well as those contained in the 2020 Selective Update of the Whitemarsh Township Comprehensive Plan. Following up on a series of Steering Committee meetings, a final draft of a new Spring Mill Mixed Use District has been completed. A 'companion' new Transit-Friendly Design Overlay District draft, that would cover much of the new Mixed Use District (replacing the current Riverfront Development Overlay District), recognizing the proximity of the Spring Mill (SEPTA) Train Station, and extending down to the river, is also in final draft form. Prior to their release and discussion by the Planning Commission, these drafts are undergoing final staff review.

Future issues of Whitemarsh Living will continue to contain updates on progress on the Zoning Ordinance Update.

1704 HISTORICAL ARCHITECTURAL REVIEW BOARD (HARB)

The Historical Architectural Review Board (HARB) is the local government body that advises the Board of Supervisors on matters pertaining to the preservation of historic land and buildings within the portion of Whitemarsh Township that is in the Plymouth Meeting Historic District (the District includes portions of Plymouth and Whitemarsh Townships). The HARB is made up of volunteers from our two communities. We meet on the second Wednesday morning of each month at 8:00AM in the Whitemarsh Township building.

HARB is required to review any construction project on properties within the Historic District that are visible from a public road. The recommendation from HARB is transmitted to the Board of Supervisors, which is required to issue a Certificate of Appropriateness for each such application before a building permit can be obtained.

HARB is happy to guide the owners of our historic land and properties through the application phase for changes and or improvements they wish to make to their property. To be placed on a HARB agenda, please contact the Planning and Zoning Department.

1704 OPEN SPACE COMMITTEE

Whitemarsh Board of Supervisors Enacts Single-Use Plastic Ban, Effective October 11, 2023

Americans use 100 billion single-use plastic bags every year. They litter our streets, parks, waterways, and natural areas. They clog our stormwater systems. It costs the Township, and all of us, time and money to clean them up. Additionally, plastic litter doesn't disappear. It breaks down into smaller particles that leach chemicals harmful to human health and to the environment.

Studies have demonstrated that plastic bag ordinances reduce plastic litter and the use of single-use bags. Many local municipalities and cities, including Philadelphia, Ambler, and Narbeth, have already enacted legislation banning single-use plastic bags. In addition, most of the towns in southeastern Pennsylvania are currently in the process of reviewing and enacting similar ordinances.

Effective October 11, 2023, the use of single-use plastic bags and non-recycled-content paper bags by retail establishments will be prohibited in Whitemarsh Township. The ordinance is based on those passed and being considered in surrounding communities to reduce confusion as shoppers travel, perhaps unknowingly, from one municipality to the next.

Since stores will no longer provide single-use plastic bags, please start using reusable bags, if you don't do so already. Bring them when you go shopping. Keep them in your car and your backpack so you're always prepared. Some exceptions to this ruling include bags for:

- Produce
- Bulk items
- Meat and fish
- Bakery goods
- Newspapers
- Dry cleaning
- Live animals

Just a note, these approved single-use plastic bags CANNOT be included in the weekly recycling because they cause significant processing problems. Please take them to the special recycling collection bins at some supermarket entrances.

Stores must provide reusable carryout bags or paper bags made with at least 40% post-consumer content for customers, as needed. Stores are required to charge at least 15 cents for each carryout or paper bag and show this charge on your receipt. The retail establishment keeps this fee.

One final requirement of the ordinance is that plastic utensils and straws will be available upon request only.

Thank you for adjusting to using reusable bags. Together, we can leave the planet healthier for ourselves, our children, and for future generations.

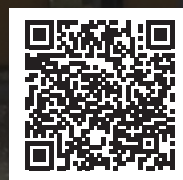

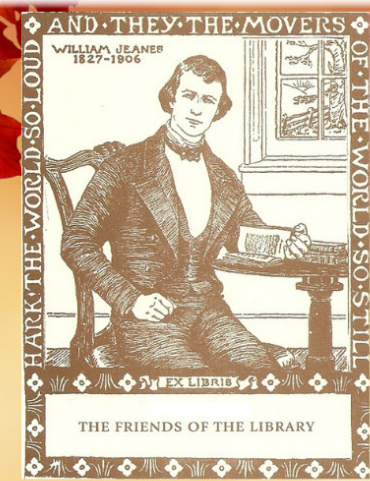

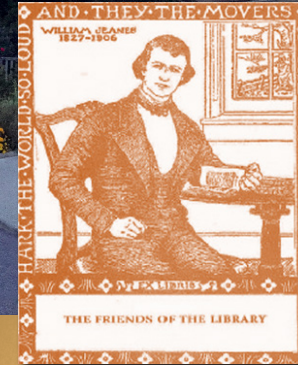
